PADA menjalankan kuasa yang diberikan oleh subseksyen 6(1A) Akta Universiti dan Kolej Universiti 1971 [*Akta 30*], Yang di-Pertuan Agong membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah (Perbadanan) Universiti di Pulau Pinang (Pindaan) 2024**.

(2) Perintah ini mula berkuat kuasa pada 1 November 2024.

UNIVERSITIES AND UNIVERSITY COLLEGES ACT 1971

UNIVERSITY AT PULAU PINANG (INCORPORATION) (AMENDMENT) ORDER 2024

IN exercise of the powers conferred by subsection 6(1A) of the Universities and University Colleges Act 1971 [*Act 30*], the Yang di-Pertuan Agong makes the following order:

Citation and commencement

1. (1) This order may be cited as the **University at Pulau Pinang (Incorporation) (Amendment) Order 2024**.

(2) This Order comes into operation on 1 November 2024.

Amendment of paragraph 1

2. The University at Pulau Pinang (Incorporation) Order, 1971 [*P.U. (A) 383/1971*], which is referred to as the “principal Order” in this Order, is amended in paragraph 1 by substituting for the words “**University at Pulau Pinang (Incorporation) Order**,” the words “**Universiti Sains Malaysia (Incorporation) Order**”.

Amendment of paragraph 2

3. Paragraph 2 of the principal Order is amended by substituting for subparagraph (c) the following subparagraph:
